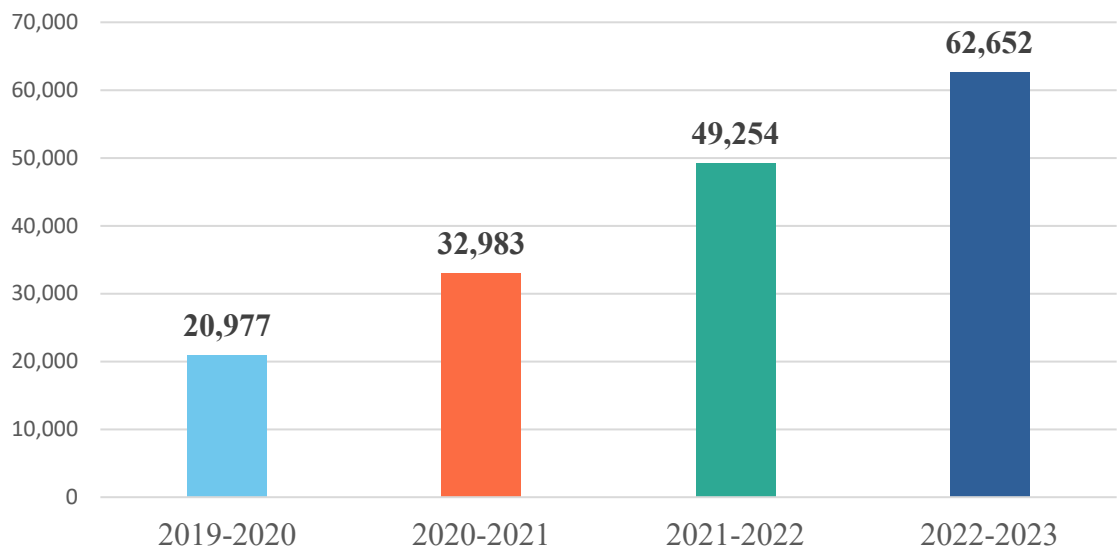

Usage Reports

Full-Text Downloads

From July 1, 2022, to June 30, 2023, the repository's total downloads increased by 27.2%. The download count reflects only the number of full-text downloads. Many items in our repository do not have full-text documents, including books, chapters, edited works, online publications that we link to from the repository. Users who visit our site to access these materials unfortunately do not generate a download. The downloads-per-item is an average over everything in the repository whether it has a full-text document or not. The chart below compares the total number of downloads in previous academic years.

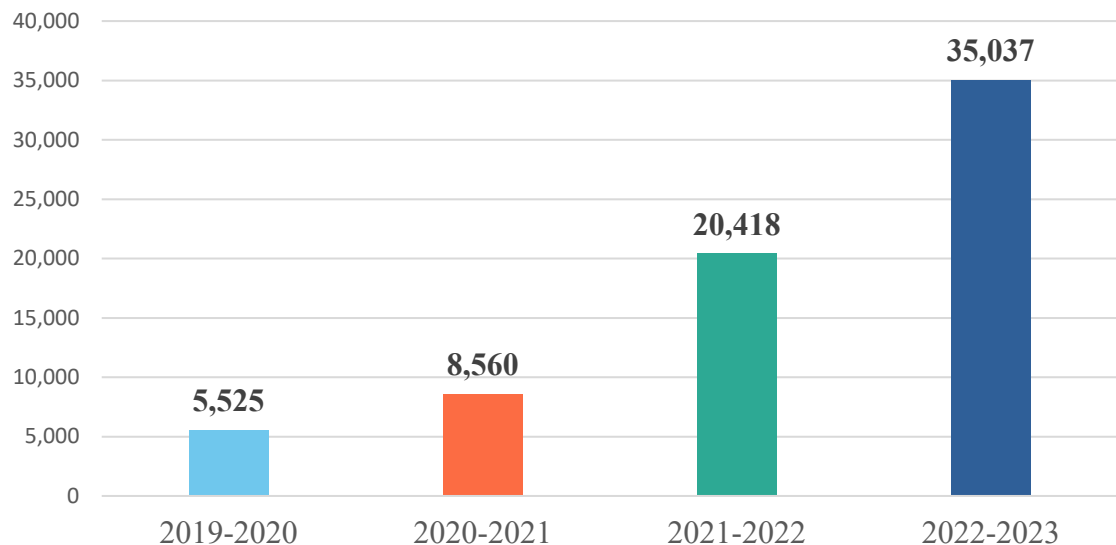

Metadata Page Hits

From July 1, 2022, to June 30, 2023, the repository's total metadata page hits increased by 71.59%. Metadata page hits can provide insights into how readers interact with a repository. These hits can occur when someone browses and searches the site, types a URL from a citation, or clicks a metadata page link in search results. However, downloads tend to be higher than metadata page hits since users frequently access full texts directly through search engines. The chart below compares the total number of metadata page hits in previous academic years.

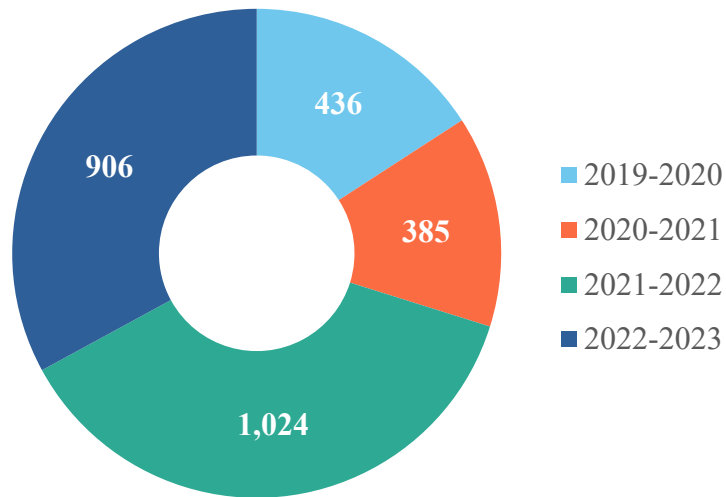

Works Posted

From July 1, 2022, to June 30, 2023, there were 906 items added to the repository, a 32.9% increase in the total number of items. This growth can be primarily attributed to the digitization of our unique special collections, as well as the uploading of faculty and student research work. The chart below compares the total number of works added in previous academic years.
