Follow the Law, Break the Mold: An Interview with Sarah Feingold, Etsy's First General Counsel

Thursday, December 2 at 6:30 p.m.

Please join the FAME Center and the Cardozo Women Alumni Group for the last FAME event of the semester. Cardozo alumna, Carrie Maylor DiCanio '08, Managing Shareholder of Anderson Kill's Denver office, will moderate a virtual discussion with trailblazer Sarah Feingold.

Born an artist, Feingold decided the best way to protect creative folks like herself was to go to law school. She then cannonballed into the position of Etsy's first attorney and 17th employee. For over nine years Feingold helped Etsy scale from an inconspicuous startup to a publicly traded company. After that, she joined Vroom as its first General Counsel. In 2018, the New York Law Journal awarded Feingold with the GC Impact Award.

Feingold is still making waves, and helping others follow suit, as the creator / writer of the play, Dirty Legal Secrets (formerly known as Legal Madness), the co-founder of The Fourth Floor, and a Fellow of NYU Law School.

You can also find Feingold speaking, advising, eating candy, hammering silver, and chasing her child.
