Letter from Director Andrea K. Schneider

Andrea K. Schneider Gives the Keynote Address at Singapore Mediation Week

Professor Andrea K. Schneider gave the keynote address at the Singapore Mediation Center on August 31, 2023. Her lecture was entitled The Next Wave of Effective Dispute Resolution: Developing Emotional and Social Intelligence. She addressed how emotional intelligence and social intuition get translated into effective negotiation and mediation, how can we make better decisions about the variety of modes of communication, and how can negotiators—and mediators—improve their own skills going forward.



Cardozo Hosts New York Peace Institute Community for Community Circle Event



On May 18, 2023, the New York Peace Institute (NYPI), hosted a restorative circle event at Cardozo School of Law. The event, developed by restorative justice practitioners Lynne Echenberg and Kailani Capote, provided attendees an opportunity to engage in a facilitated dialogue designed to rebuild and strengthen community in a post-pandemic world. NYPI is a long-time partner of the Cardozo Law School Mediation Clinic and offers mediation, facilitation, restorative justice, conflict coaching and dispute resolution services to the New York City community.



Cardozo Students Present at National Center on Restorative Justice Symposium

Jordan Stark '23 and Jennifer Grubman '25 participated in The National Center on Restorative Justice's symposium on Restorative Justice in Legal Education as panelists on September 15, 2023. As a part of the panel discussion on Restorative Justice Integration in J.D. Curriculum, Stark discussed incorporating restorative justice into ADR programs and courses, and Grubman discussed incorporating restorative justice into the civil procedure curriculum. During the spring 2023 semester, Stark conducted an independent study project on Restorative Justice and ADR under the supervision of Professors Amanda Berman and Hillary Packer, who teach a course entitled Innovations of Justice at Cardozo. During the summer of 2023, Grubman was awarded James B. Boskey Restorative Justice Fellowship and worked with Nichusak (meaning "my women friends" - women speaking to women in Lenape) and the Cardozo Law Institute in Holocaust and Human Rights working to prevent and adequately responding to the crisis of Missing and Murdered Indigenous Women, Girls and Two-Spirit people (MMIP) in Lenapehoking, the traditional homeland of the Lenape.



Cardozo Welcomes New Dispute Resolution Adjunct Faculty

JCardozo welcomes new professors Amanda Berman, Adria Gulizia, Hillary Packer, Rekha Rangachari, and Stephen Wah.

Berman is the Deputy Director of Regional Programs at the Center for Justice Innovation ("CJI") and Packer is the Associate Director of Restorative Practices at CJI. They will be teaching a course entitled Innovations in Justice, which introduces students to the innovative ideas and practices around a justice approach where individual and community building and healing are at the forefront in the wake of dysfunction, calamities and crimes.

Gulizia is the director of court and community programs at the New York Center for Interpersonal Development and will teach ADR in the Workplace. The course is designed to familiarize students with the variety of ADR modalities used to address conflict in the workplace.

Rangachari is the director of the New York International Arbitration Center, and will be teaching International Commercial Arbitration, and Wah, a managing associate at Pasich LLC, will serve as the Faculty Coach for the Cardozo Dispute Resolution Honor Society team members participating in the Willem C. Vis International Commercial Arbitration Moot.



New Kukin Program ADR Courses: The Law of Settlement & International Peacemaking: Israel

This fall, Professor Brian Farkas created a new course called The Law of Settlement. The course focuses on what happens to the 92%-98% of civil cases that are resolved before trial. Why do so many cases settle? When do they settle? And—perhaps most importantly—how can attorneys facilitate settlement in a manner that is most advantageous for their clients? This course considers the full spectrum of processes for resolving civil conflicts and how and when a case settles. The course also explores best practices for crafting settlement agreements, issues with compliance, and rules for professional conduct that guide settlement negotiations and agreements.

Professor Andrea K. Schneider will teach a new course entitled International Peacebuilding: Israel. The class will meet over the course of the entire year and is scheduled to travel to Israel to study these issues in person during the second week of the January Winter session, depending on the circumstances on the ground. The case study of Israel will be used for the course focusing on the Israeli-Palestinian conflict, coexistence projects, Israeli Arab relations, and the integration of dispute resolution into the Israeli legal system. The course will also offer students insights into different tools of conflict resolution as applied to external as well as internal disputes and conflicts.



Cardozo Students Awarded AAA-ICDR Diversity Scholarship Training Grants

Caterina Cesario LL.M. '23, Xènia Campàs Gené LL.M. '23 and Alejandro Martínez LL.M. '23 were awarded the American Arbitration Association (AAA) International Center for Dispute Resolution (ICDR) Diversity Scholarship Grants. The scholarship provides diverse law students with financial assistance for their participation and attendance at well-recognized conferences.

Cesario and Campàs Gené attended the 25th Annual ABA Section of Dispute Resolution Spring Conference in Las Vegas. The conference is the largest ADR one in the world and brings together the nation's top dispute resolution professionals, including arbitrators, mediators, negotiators, lawyers, and legal professionals.

Martínez attended the 35th Annual Institute for Transnational Arbitration Workshop and Annual Meeting in Austin, Texas. The event theme was Remedies in International Arbitration: Wielding Arbitral Power for Effective Redress.



Hear from Cardozo James B. Boskey Restorative Justice Fellows Jennifer Grubman '25 and Ethan Graham '24

Established in 2019, the Boskey Restorative Justice Fellowship was founded thanks to a generous grant from the James B. Boskey Memorial Foundation. Each year, Kukin Program faculty competitively select two students to serve as Boskey Restorative Justice Fellows. One fellowship is with Nichusak, the Lenape Center's Working Group on the Missing and Murdered Indigenous Women's Crisis, and the Cardozo Law Institute in Holocaust and Human Rights (CLIHHR). The second fellowship is with the Redhook Community Justice Center. Jennifer Grubman '25 and Ethan Graham '24 were selected as the 2023 Boskey Restorative Justice Fellows.

Jennifer Grubman '25

As a Boskey Restorative Justice Fellow, I had the honor of working with the Lenape Center and the National Indigenous Women's Resource Center (NIWRC). For the Lenape Center, I worked on a white paper to be released by Nichusak, the Center's working group on the Missing and Murdered Indigenous Persons crisis (MMIP). The white paper will tie together MMIP with the forced removal of Indigenous children (both historical and current-day practices) and will offer restorative-justice driven recommendations for both crises. For NIWRC and its Safe Indigenous Housing Center (STTARS), I contributed to developing a tribal housing law database. A lack of safe housing perpetuates MMIP as it leaves survivors of gender-based violence vulnerable to cycles of re-victimization. Even when accommodations are available, specific policies and practices (e.g., one-strike evictions, nuisance ordinances, and prohibition on pets) are not survivor-friendly. Once complete with housing codes from the 574 federally recognized tribes, NIWRC and STTARS plan not only to make the database available to tribes and domestic violence advocates but also to use it to develop an intersectional, survivor-centric model

tribal housing code. My fellowship was invaluable in that it granted me the privilege of learning from the expertise and learned experience of the brilliant Indigenous individuals working on the frontlines of the MMIP crisis.

Ethan Graham '24

This past summer, I had the opportunity to work as a Boskey Restorative Justice Fellow at the Center for Justice Innovation's Red Hook Community Justice Center (RHCJC). RHCJC, in addition to being the nation's first multi-jurisdictional community court, acts as a one-stop-shop for the Red Hook community when it comes to providing justice. public safety, and a wide array of community projects. Working at RHCJC was a deeply impactful experience, and the opportunity expanded my knowledge and understanding of restorative justice and its trajectory both on a macro level in the United States and on a micro level in Brooklyn. My work for the Center consisted primarily of two projects. The first was to research and write a memo on restorative justice practices for felonylevel offenses across the country, as RHCJC is evaluating what it may look like to expand its restorative justice practice. The second project was related to the relationship between discriminatory practices against individuals with arrest and conviction records, housing insecurity, and high rates of recidivism. In addition to the knowledge gained from these projects, the chance to observe court, spend time with and learn from the staff, and participate in community projects showed me the far-reaching impacts of community-centered justice and alternative forms of dispute resolution. After my summer as a Boskey Fellow, I hope to remain involved in Restorative Justice in some capacity throughout the duration of my career.
