[Professor Jessica Roth Appears on MSNBC to Talk About the Roger Stone Indictment and Russian Hacking of Documents](#)

Professor Jessica Roth weighed in on the Roger Stone indictment on MSNBC on January 25. "This is the missing piece of the puzzle that we've been looking for Mueller to lay out– the connection between the Trump campaign and WikiLeaks...this indictment lays out precisely how that was happening through Roger Stone."

Professor Roth appeared on MSNBC's *Velshi and Ruhle* on January 31 to discuss the issue of Russian hackers altering Mueller case documents and the protective order issued to prevent further tampering. "This way, lawyers are supposed to be able keep control of the information," she said.

Professor Sam Weinstein spoke with Reuters about the integration of WhatsApp, Instagram and Facebook Messenger, and pointed out that integrating the messaging services could make it harder for antitrust regulators to break up Facebook. He said, "If Facebook is worried about that then one way it can defend itself is to integrate those services."

During an interview on WNYC, Professor Lindsay Nash said local police departments must be made aware that they cannot detain someone for immigration enforcement, as per a state appellate court ruling. She said, "It's critical for a police department that large to know how to implement the court's decision, how they have to change their practices. And frankly, the consequences of them not knowing the law and arresting someone without authorization are significant."

P*LAW Week 2019 Brought Local Leaders to Inspire Students

Cardozo's annual Public Law Advocacy Week took place at Cardozo Law from January 28 through 31. This year's programming covered topics such as efforts to ban LGBTQ conversion therapy, education, reproductive rights and changes in the landscape around immigration.
