During the round, another volunteer will time the rounds, and at designated marks (i.e. 10 mins, 5 mins, 3 mins, 1 mins) you will hold up time cards for competitors and judges. For this position, you will need to dress as if you are going to court (business attire).

If you have any interest in trying out for the Moot Court Honor Society, this is a really great opportunity to watch a real moot court competition and interact with Society members (participating as a bailiff in no way guarantees membership.) However, we encourage everyone (regardless of MCHS interest) to get involved with this exciting event and act as an ambassador for our school.
