Professor Pamela Foohey Comments, in USA Today, on the Need for Easier Discharge of Student Loan Debt in Bankruptcy

“I think they could work faster,” Foohey said. “It’s been too long.” During the campaign, Biden pledged to end the rules that made it difficult to discharge student loan debt in bankruptcy.

“The categories of information they’re talking about are pretty broad,” said Wansley. “Are there trade secrets in that set of information that they sent? Probably, there are some. Does it include all of the information they sent? Almost certainly not.”

The case “could be extraordinarily important, it could be moderately important, or it could be a case the court just dismisses on a belated realization that there’s no live controversy at all,” Shaw said. “The fact that the court took the case at all is concerning to me and suggests the court may want to use this case as a vehicle to really change the law.”



Professor Christopher Buccafusco's Working Paper on Price Gouging in the Pandemic Cited in Fortune

“Consumer norms about fairness seem pretty flexible. So what people think is fair can be highly context dependent,” said Buccafusco. According to the working paper he co-authored, the majority of U.S. consumers did not think the price increase in hand sanitizer at the beginning of the pandemic was unfair.

Video: Cardozo's Civil Rights Clinic Improves Conditions for People on Death Row

Cardozo's Civil Rights Clinic, led by Professor Betsy Ginsberg, won a major settlement in a class-action lawsuit on behalf of those on death row at Louisiana State Penitentiary at Angola. A federal judge in Louisiana found the settlement reached by the parties in a lawsuit brought by people sentenced to death to be fair and in the interest of justice. This order follows litigation by Cardozo's Civil Rights Clinic, partnering with lawyers from the New York City office of Hogan Lovells and New Orleans lawyer Nicholas Trenticosta.
