#### [Professor Betsy Ginsberg Testifies Before US Commission on Civil Rights](#)

Professor Betsy Ginsberg testified in Washington, D.C. before the U.S. Commission on Civil Rights at its briefing on *Women in Prison: Seeking Justice Behind Bars* on February 22.

Professor Kate Shaw writes in *The New York Times*: "Will the White House be able to use executive privilege to successfully block investigators from getting information? When executive privilege and congressional oversight collide, who wins? This is a complex question that federal courts, and perhaps ultimately the Supreme Court, may have to answer."

Professor Jessica Roth told Brian Williams, "I was shocked by this sentence...it was extraordinarily low as a sentence and also when you think about the magnitude of the crimes, eight felony counts of conviction, and some were for crimes where the jury found he willfully violated the law."

#### [Professor Ed Zelinsky Writes on Rice Trust Case in \*Law360\*](#)

Professor Ed Zelinsky offered perspective on the Rice trust case, already heard by the North Carolina Supreme Court and soon to be heard by the US Supreme Court: "The North Carolina court is correct on both points. While the U.S. Supreme Court's decision in *South Dakota v. Wayfair Inc.* modified Quill's construction of the commerce clause, Wayfair left intact Quill's due process analysis. The North Carolina Supreme Court properly applied that analysis in *Kimberly Rice Kaestner 1992 Family Trust* and thus should be affirmed," he wrote.

## Floersheimer Center and Cardozo Data Law Initiative Host Tech Talk on International Cyber Laws

Professor Deborah Pearlstein led the discussion with Duncan B. Hollis, Professor of Law at Temple Law School. They talked election hacking, fake news and setting global cybersecurity standards at “The Emergence of Global Cybernorns” event on March 7.

## Sports Law Symposium Covered by Associated Press: Articles in *The Washington Post* and other news outlets

*The Associated Press* covered Cardozo's Sports Law Symposium held Friday, March 1, quoting Assemblyman Gary Pretlow on the proposed legalization of sports betting and in-person wagering at places like Yankee Stadium and Madison Square Garden: "That is one of the changes, that we would open it up to have affiliates such as Madison Square Garden, which has expressed an interest in doing this. I think it's a great idea."
