Victor Harris was left quadriplegic at 19 after he was deliberately rammed off the road in a high-speed chase with police on the back roads of Georgia. Justice Scalia, writing for an 8-1 majority, exclaimed that "no reasonable juror" could argue that this use of deadly force was unwarranted given Scott's driving and challenged the world to see for themselves, posting dashcam video from the chase to the Supreme Court's own website, a historic first.

In the spring of 2019, Professor Ronald Sullivan of Harvard Law School agreed to join the group of lawyers representing Harvey Weinstein, whose alleged crimes and tortious conduct against women helped launch the #MeToo Movement.

At the time, Professor Sullivan also served as the resident dean of one of Harvard College's residential houses. When his decision became public, he was fiercely criticized by many who considered his defense of Weinstein incompatible with his role as faculty dean. The panel will address the ethical questions presented by the Sullivan case, including to what extent lawyers should consider their other professional and personal commitments before electing to represent a client.
