Moot of Upcoming Argument in the Second Circuit Court of Appeals

Please join the Center for Rights and Justice and the Cardozo Chapter of the National Lawyers Guild for a moot of the upcoming argument in *Edrei v. City of New York*, a case about the NYPD's use a Long Range Acoustic Device (a/k/a Sound Cannon) at a Black Lives Matter demonstration, before the Second Circuit Court of Appeals this month. Gideon Oliver and Elena Cohen—attorneys for the Plaintiffs and former Presidents of the NYC Chapter of the National Lawyers Guild—will argue their case, Professor Ginsberg will play the role of the lawyer for the City of New York, and they will be judged by John Boston, former Director of the Legal Aid Society's Prisoners' Project, Rachel Meeropol, Senior Staff Attorney at the Center for Constitutional Rights, and Professor Alex Reinert. The moot will be followed by a Q&A with the advocates, Professors Betsy Ginsberg and Alex Reinert, and Keegan Stephan, a current Cardozo law student and one of the plaintiffs in the case.

After the film, join Indie Film Clinic Director, Michelle Greenberg-Kobrin and CLIHHR Director, Jocelyn Getgen-Kestenbaum for a conversation.

"1945" is a film about Orthodox man and his grown son return to a village in Hungary while the villagers prepare for the wedding of the town clerk's son. The townspeople - suspicious, remorseful, fearful, and cunning - expect the worst and behave accordingly. The town clerk fears the men may be heirs of the village's deported Jews and expects them to demand their illegally acquired property back. Director Ferenc Török paints a complex picture of a society trying to come to terms with the recent horrors they've experienced, perpetrated, or just tolerated for personal gain. A superb ensemble cast, lustrous black and white cinematography, and historically detailed art direction contribute to an eloquent drama that reiterates Thomas Wolfe's famed sentiment: you can't go home again.
