Join the Cardozo Arts and Entertainment Law Journal to discuss the progression of Section 230 over the past 25 years. Keynote speaker and Professor, Jeff Kosseff, coined the phrase, “the twenty-six words that created the Internet,” in reference to Section 230 of the 1996 Communications Decency Act, which gives online platforms, such as Twitter and Facebook, immunity from user-generated speech posted on their platforms and also allows platforms to moderate and/or “censor” the content posted on their platforms.

This symposium brings together leading scholars and practitioners to discuss how Section 230 has shaped online platform regulation, as well as the law’s shortcomings from both user-focused and platform-centric perspectives. The discussion will debate the trajectory of the law and identify where limits, if any, to Internet immunity should start.
