Professor Deborah Pearlstein spoke on a panel hosted by The Cato Institute, about President Trump's border security national emergency declaration. "The primary problem with the President's recent invocation of the National Emergency Act is a statutory problem, not a constitutional problem," she said.

Professor Jessica Roth was a guest on several shows including *The 11th Hour with Brian Williams*, *Bloomberg Daybreak* and CBC's *The National*, to talk about the aftermath of the Mueller Report and next steps for the Southern District. She said on *The 11th Hour*, "you couldn't have a more perfect overlap between this final critical question that Mueller was facing and what Barr wrote about in that memo right before he was appointed to that position and that to me is tragic, because the whole point of appointing a special counsel is to avoid the appearance of a conflict of interest and now we have precisely that issue."

### [Professor Edward Zelinsky Writes in \*Law360\* on Citizens Living Abroad](#)

Professor Edward Zelinsky wrote in *Law360* on the Duchess of Sussex Meghan Markle's taxation as a United States citizen living abroad. Despite her marriage into the British royal family, U.S. tax law still requires Markle to pay taxes since she earns above \$105,900 annually. "The U.S. thus taxes the income of a citizen living abroad only when that citizen both has high income and pays little or no income taxes to the nation in which she resides," writes Zelinsky.

### [AELJ Symposium Addresses Digital Art and Blockchain](#)

The Cardozo Arts & Entertainment Law Journal hosted its spring symposium on March 28, focusing on digital art and blockchain, the challenges to art law and the intersection of blockchain technologies and the legal processes governing art transactions. Professors

Christopher Buccafusco and Jeanne Schroeder were moderators. Panelists were in agreement that blockchain opened the doors to collaborating on artwork and democratizing art.
