## Cardozo Welcomes Six New Faculty Members

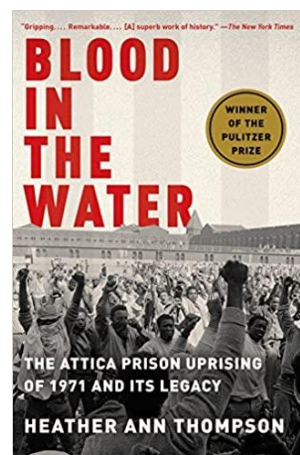
