### 100 Days of Dissent: Unpacking the Ongoing Indian Farmers' Protests April 12, 12:00PM ET

For months, Indian farmers have been protesting, building a resistance movement against harmful agricultural law reforms that seek to strip them of essential protections and open the door to multinational agribusiness investment. The new laws will make farmers' goods vulnerable to private traders, essentially leaving them unprotected under a free market mechanism. These actions have caused a strong mobilization of opposition with millions of farmers concerned that their livelihoods are at risk as they will lose their ability to provide for their families. Many farmers are also members of the Sikh/Punjabi community and have been targets of violence and discriminatory laws. CLIHHR's discussion with Vinay Sreenivasa, community attorney/advocate with the Alternative Law Forum, will focus on the agricultural reform laws, the laws' impact on human rights, and how the laws are a continuation of discrimination against the Sikh/Punjabi minority community in India.

#### Speakers

**Vinay Sreenivasa** is a community attorney/advocate with the Alternative Law Forum. His areas of interests include Urban Transport, Urban Poverty, Informal Sectors and Urban Governance. He has

also been part of initiatives promoting Free and Open Source Software in the government. Vinay holds an engineering degree and was in the IT industry until 2007. His research and reflections have been shared across multiple media outlets. Vinay's recent article in the 'Logical Indian' spotlights how India's farm laws may lead to the collapse of the sector that is already in a precarious situation.

**Ramya Jawahar Kudekallu** is Visiting Instructor of Clinical Law at Cardozo's Benjamin B. Ferencz Human Rights and Atrocity Prevention Clinic and CLIHHR's Telford Taylor Teaching Fellow. Her work focuses on the rights of minorities and atrocity prevention through international intervention. In 2018, Ramya graduated from Fordham School of Law with an LLM in International Law and Justice. Later that year, she secured the Crowley Fellowship with the Leitner Center for International Law. She has taught a Human Rights Scholarship class and has conducted research on labor, gender-based discrimination and access to justice.
