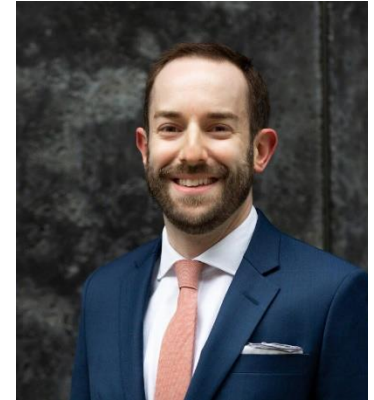

“Last month, Montana became the first U.S. state to pass a bill banning TikTok from operating within its borders,” Pearlstein and Dellamore wrote. “If Governor Greg Gianforte signs some version of the bill, it will become the first statewide ban in the country to take direct aim at the popular social media app, which various U.S. government officials have warned poses a serious national security threat.”

“I think it does [make sense that Trump will not testify],” Roth said. “I think he would be a very, very challenging witness, and he has lots of exposure in all his other cases. I think from his attorney's perspective, it makes a lot of sense that he would not testify.”
