“Along with other contemporaneous evidence, including legislative history, it helps to show that Congress meant to fully enforce the Reconstruction Amendments via a powerful new cause of action,” Reinert said.

“Thus, before we assign too much significance to this moment, it's worth pausing to consider just how unusual this case was,” Roth wrote. “That it involved the former president of the U.S. is just a piece of what made the case so unique. The jury is still out on what lasting impact, if any, Carroll's case will have on the ability of other survivors of sexual assault to obtain justice.”

“There's a finding here that Judge Fitzpatrick's belief that expanded panel rehearings in the Adidas-Nike case was unlawful,” Vishnubhakat said. He said it's likely the office will appeal to “get a contrary holding, one that says that any belief that this is unlawful can't be reasonable because as long as a belief to the contrary is reasonable, there's a cloud of doubt of legality over what they are capable of doing under the [office's] standard operating procedure.”
