
"Prosecutors will do a lot of investigation and take a lot of care before they even decide to charge a police officer. It could take a year," Levine tells <u>USA Today</u>. "Natural favoritism and the bias in favor of police is always going to be the biggest obstacle," Levine says to <u>Insider</u>. She further noted, "it's one trial, in one city, of a really bad guy, and my feeling is no matter what happens in this trial, very little will change in policing."
