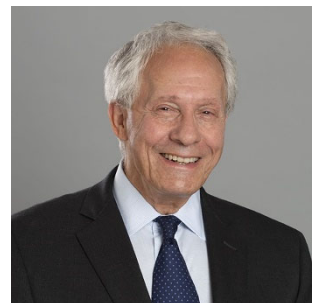
Professor Kate Shaw Discusses the SCOTUS Leaked Document and the Future of Roe v. Wade on ABC’s Start Here
