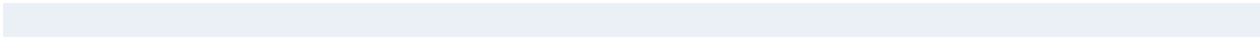
Maria F. Garcia-Syngros '22 Named A 2022 Equal Justice Works Fellow
