The *New York Daily News* interviewed 10 legal experts - including Cardozo Professor Jonathan Oberman - about Manhattan District Attorney Cy Vance Jr.'s decision two years ago to not charge Harvey Weinstein after Ambra Battilana Gutierrez accused him of sexually assaulting her. In the article, Oberman said a jury would have found the required intent in this case.
