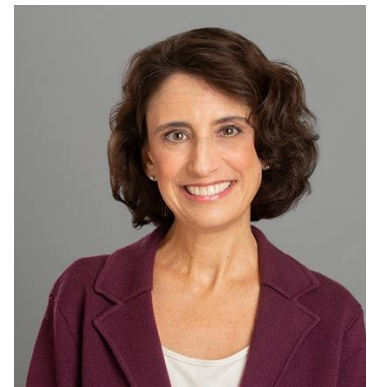
Ukrainian Professor Dmytro Vovk Finds a Safe Haven at Cardozo

Professor Deborah Pearlstein Pens Op-Ed in New York Times on Trump Classified Documents Case

“Among the criminal charges the former president of the United States now faces, the most extraordinary are 31 counts of violating the Espionage Act, a century-old law prohibiting the unlawful retention of ‘information relating to the national defense,’” Pearlstein writes. “Barring a guilty plea — the more common resolution in a case as strong as this — those charges will most likely eventually go before a jury.”



Professor Kate Shaw Discusses Trump Indictment on ABC News Special Report

“I think it is important [that Jack Smith, Special Counsel for the United States Department of Justice, who indicted Trump, gave a statement to the American people] and I also think it was correct for him to have kept it very short,” Shaw said. “So he spoke only for a few minutes, he emphasized the important bedrock constitutional principle of a presumption of innocence, and that presumption applies full-force to the former president.”

“A lot of athletes have to file lots of returns,” Zelinsky said. “These kinds of taxes on non-residents income have been on the books for years.
