**Lawyers, Guns, and Money: The Second Amendment in American Politics and Law**

**Monday, April 15, 12 - 1pm, Fifth Floor Faculty Lounge (512)**

Lunch will be provided.

Professor Saul Cornell (Fordham University) is one of the nation's leading authorities on early American constitutional thought. He has contributed to numerous amicus curiae briefs in court cases involving the Second Amendment, including most notably as the co-author of an amicus brief filed in

*District of Columbia v. Heller*. Professor Cornell has been a Visiting Scholar at the Floersheimer Center for the Spring 2019 semester.

On April 15<sup>th</sup> at noon, please join us for a discussion of the current state of the Second Amendment, ten years after

*Heller*. Saul will be in conversation with Professor Kate Shaw, Co-Director of the Floersheimer Center and former Clerk for Supreme Court Justice John Paul Stevens.

Among other topics, they will discuss *New York State Rifle & Pistol Association Inc. v. City of New York, New York*, which is slated to be argued next fall before the Supreme Court.
