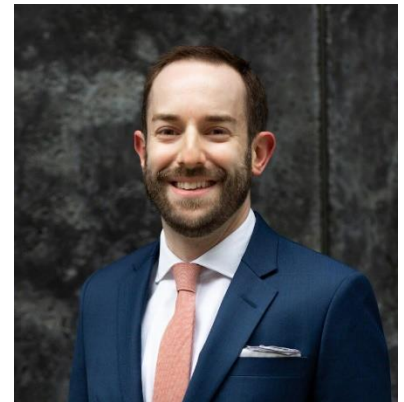
Professor Jessica Roth Appears on CNN's AC360 to Discuss Trump Documents Case

“One of the concerns about Judge [Aileen] Cannon is will she delay the proceedings in a way that favors former President Trump and what he might be seeking here in terms of getting this prolonged into the political season,” Roth said. “So I thought the fact that she seemed to seize the bull by the horns and issue an order that was actually a relatively tight scheduling order was a good sign.”
