Professor Stewart Sterk Cited by SCOTUS

Professor Stewart Sterk's article "The Demise of Federal Takings Litigation" was cited by both the majority and the dissent in the U.S. Supreme Court's opinion on *Knick v. Township of Scott*, dealing with compensation for private property owners when the use of that property is taken from them by state or local governments, under the Due Process Clause of the Fifth Amendment.

Cardozo Premieres "Unboxing the Law" on YouTube

Cardozo's new series began this week with two YouTube videos, featuring our faculty as they dissect the latest Supreme Court decisions. New faculty members Kate Levine and Kathryn Miller talked about *Flowers v. Mississippi* and Professor Stewart Sterk discussed *Knick v. Township of Scott* with Professor Michael Pollack.

Professor Ekow Yankah Gives Perspective to *Bloomberg Law* about Flowers v. Mississippi

Professor Ekow Yankah spoke with Bloomberg Law about SCOTUS' ruling in *Flowers v*. *Mississippi* that favored a black death row inmate tried six times for the same crime by the same local prosecutor: "It's clearly a step forward...but when the court goes out of its way to say this is an extraordinary case, that's a discouraging signal." It's a boon only for "the most egregious cases of repeated racial discrimination that are incredibly well-documented."

Professor Kate Shaw to Co-Host New SCOTUS Podcast

Professor Kate Shaw will co-host "Strict Scrutiny," a new podcast about the Supreme Court and the legal culture that surrounds it, starting in the fall of 2019.
