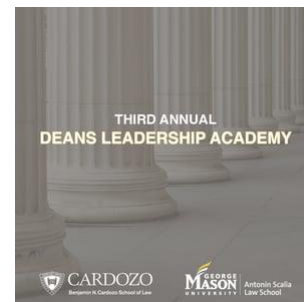
"Cardozo is a special place and a special community that has nurtured me throughout my academic career. I look forward to doing my part to help the institution thrive in the coming years," Wu said.
