Are We Already Living in a "Black Mirror" World? A Conversation About AI, Law, and Corporate Ethics

Black Mirror is an Emmy Award-Winning British anthology TV series that explores near-term techno-dystopias. How close are we to living and working in a Black Mirror world? Many of the episodes highlight cases of AI running amok, involving implantable devices in the body, drone artificial insects, new forms of social media, and novel types of AI-enhanced consciousness, all of which are capable of being hacked, manipulated or controlled in unintended ways. As practicing lawyers in a world of emerging AI apps, we all may be expected to provide advice to a range of corporate and public sector clients on the novel legal issues posed by this new technological landscape. Distinguished speakers will lead a lively session, as we explore the "creepier" aspects of the coming world of AI, and will discuss the legal and ethical issues that we may soon all be facing.

From Murder To Museums: Abraham Lincoln, Adolf Hitler and The Hunt For Nazi Looted Art In America

In their presentation,

From Murder To Museums: Abraham Lincoln, Adolf Hitler and the Hunt For Nazi Looted Art in America, Raymond J. Dowd, Partner - Dunnington Bartholow & Miller LLP - NYC, and Samuel A. Blaustein, Partner - Dunnington Bartholow & Miller LLP - NYC, recount how they seized two stolen Schieles after they were spotted at the Salon+Art Show at the Park Avenue Armory in November 2015, leading to international headlines upon their restitution to their clients. The Schieles are now at Christie's with an appellate court blocking the sale.

The presentation traces Abraham Lincoln's idea of taking the profit out of war through the Lieber Code Executive Order 100 of April 1863, to the 1899 and 1907 Hague Conventions, to the Nuremberg Trials, to show that returning the stolen property to Holocaust victims was an American idea.

The attorneys discuss how 1. Confiscatory US tax laws, 2. A fair market value deduction for artworks donated to museums, and 3. An unwillingness of museums to look gift horses in the mouth led to the current situation of US museums having to deal with large inventories of unprovenanced works that left Europe after 1933 but were created prior to 1946.

This confluence of circumstances has led to history's greatest robbery being concealed by history's greatest murder.

Fernando Travesi is the Executive Director of the International Center for Transitional Justice (ICTJ). He has over 20 years of international experience in transitional justice, human rights, and rule of law. Prior to joining ICTJ in 2014, he was the Director of the UNDP Transitional Justice Basket Fund in Colombia. He also served as UNDP Senior Justice Advisor in Tunisia after the Jasmine Revolution.

Lauren Wyatt, an attorney from Catholic Charities Immigration Services, will train students to volunteer in immigration court! 1Ls, 2Ls, 3Ls, and LLMS are welcome.

---No second language required and no immigration experience necessary.

More about the program: This is an excellent opportunity to get hands-on legal experience in immigration. It looks great on resumes and will likely be a talking point during interviews. After the training, Catholic Charities will offer a list of dates when students can sign up to go to immigration court for the day with the "Immigration Court Help Desk" program. Students will get to interview clients and fill out intake forms to help determine which immigration relief options people may be eligible for.
