Professors Matthew Wansley and Sam Weinstein Speak to Fortune About Venture Capitalists Using Illegal Pricing Strategies

“I don’t think most [venture capitalists] come into an investment thinking ‘we’re gonna win with predatory pricing,’” Wansley said. “But I think once they have an investment where it seems like there’s some growth potential, and they know that consumers are very sensitive to cost, then all of a sudden, predatory pricing looks attractive.”

“I think that the May 2024 date is reasonable,” Roth said. “I think that it is consistent with other similar cases, and I think, just as importantly, the reasoning that the judge explained in her order setting the new schedule was legally sound given the extent of the discovery and the legal issues that will have to be litigated with respect to the use of classified information.”
