#### From Murder To Museums: Abraham Lincoln, Adolf Hitler and The Hunt For Nazi Looted Art In America

In their presentation,

From Murder To Museums: Abraham Lincoln, Adolf Hitler and the Hunt For Nazi Looted Art in America, Raymond J. Dowd, Partner - Dunnington Bartholow & Miller LLP - NYC, and Samuel A. Blaustein, Partner -Dunnington Bartholow & Miller LLP - NYC, recount how they seized two stolen Schieles after they were spotted at the Salon+Art Show at the Park Avenue Armory in November 2015, leading to international headlines upon their restitution to their clients. The Schieles are now at Christie's with an appellate court blocking the sale.

The presentation traces Abraham Lincoln's idea of taking the profit out of war through the Lieber Code Executive Order 100 of April 1863, to the 1899 and 1907 Hague Conventions, to the Nuremberg Trials, to show that

returning the stolen property to Holocaust victims was an American idea. The attorneys discuss how 1. Confiscatory US tax laws, 2. A fair market value deduction for artworks donated to museums, and 3. An unwillingness of museums to look gift horses in the mouth led to the current situation of US museums having to deal with large inventories of unprovenanced works

that left Europe after 1933 but were created prior to 1946. This confluence of circumstances has led to history's greatest robbery being concealed by history's greatest murder.

Please join The Floersheimer Center for a book talk and discussion of the history, future, and proper role of presidential impeachment in the United States. Professor Kate Shaw will speak with Joshua Matz about his new book (written with Harvard Law Professor Laurence Tribe), *To End a Presidency: The Power of Impeachment*, which provides a measured guide to prior impeachment efforts and argues that we must rethink impeachment as an option for the twenty-first century.

Joshua Matz is a widely published constitutional scholar and former clerk for Justice Anthony Kennedy. He is the author of 2014's award-winning Uncertain Justice: The Roberts Court and the Constitution, also with Tribe.

Joshua is of counsel at Kaplan Hecker & Fink LLP and Gupta Wessler PLLC. In addition to his commercial work in trial and appellate litigation, he also maintains a diverse civil rights practice and has litigated questions relating to LGBTQ rights, religious liberty, freedom of speech, defamation liability, the Second Amendment, and the Emoluments Clause.
