Cardozo School of Law is pleased to announce that Merchant & Gould, a national intellectual property law firm with clients in the Northeast region, will fund The Merchant & Gould Intellectual Property Diversity Scholarship to support Cardozo students from diverse backgrounds seeking a career in intellectual property law.

Cardozo's Intellectual Property & Information Law Program is one of the top ten in the country, according to U.S. News & World Report Rankings. Merchant & Gould selected Cardozo as one of nine schools with recipients of the student scholarships, which will be awarded to one incoming 1L student each year, beginning in Fall 2021.
