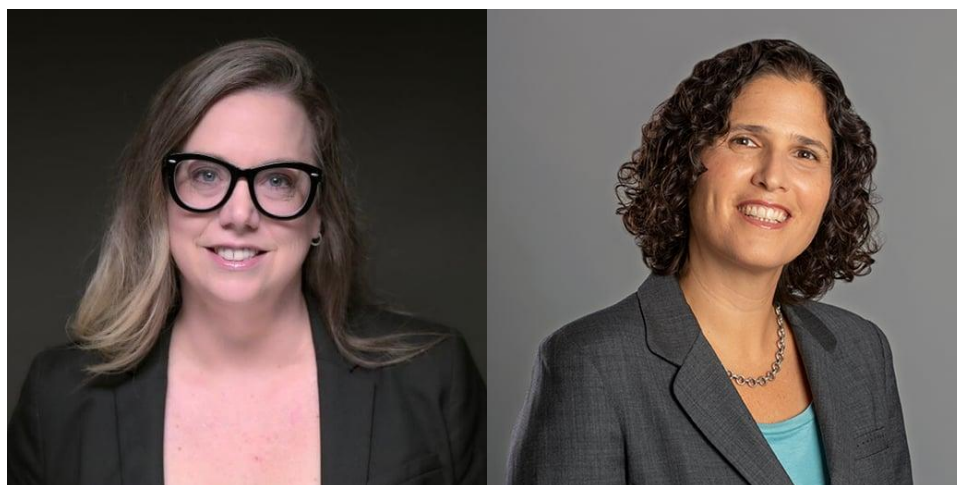

Carey Bertolet Grand is the dean of Career Services. Prior to joining Cardozo, she worked for 15 years as a legal search

consultant placing experienced lawyers in law firms and corporations. She started her legal career as a commercial litigator with the Texas law firm Winstead, and then opened the New York office of BCG Attorney Search, establishing the company's footprint as a national legal recruitment company. After that, she joined Laurence Simons International, a London-based legal and compliance recruitment agency, where she served as a Managing Partner.

Betsy Ginsberg is the Director of Clinical Education and Clinical Professor of Law at Cardozo, where she founded and directs the Civil Rights Clinic. Professor Ginsberg began teaching at Cardozo in 2010, first in the Immigration Justice Clinic and then in the Civil Rights Clinic. She came to Cardozo from New York University School of Law, where she taught in the lawyering program. Prior to teaching, Professor Ginsberg litigated class actions as a Staff Attorney with the Prisoners' Rights Project at the Legal Aid Society, where she sought to reform jails and prisons in New York City and New York State with respect to disability rights, mental health care and prison guard brutality. Professor Ginsberg's scholarship explores issues relating to access to courts for civil rights litigants with a particular focus on barriers to relief for institutionalized persons.
