#### [Professor Stanley Fish writes Op-ed in \*Daily News\*](#)

Professor Stanley Fish wrote in a *Daily News* op-ed regarding the NBA/China Twitter controversy, "When Senate Majority Leader Mitch McConnell warned the National Basketball Association not to put profits ahead of free speech, he joined a chorus of many, including President Trump, who have miscategorized the tiff between China and the league. The controversy is a complicated one and touches on many concerns, but freedom of speech isn't one of them. There is no free speech issue in sight."

Three of the country's top drug distributors and a drug manufacturer announced a settlement, marking a significant development in the legal fight over accountability for the nation's opioid epidemic. "There are now thousands of cases, but this will set a precedent on pricing," Professor Ekow Yankah told *The Hill*. "This, to me, sets a baseline market rate for liability, and only the people who really want to gamble are the ones who will take the next phase to trial."
