- Contact email

Each text may be included twice in the Today at Cardozo email. Once under the "Upcoming Events" section and once under the "Today at Cardozo" section. When sending any text please specify the two dates you would like it to be included and its corresponding section.

Lastly, the announcement could only go out once a day so please be sure to review the text before sending the request.
