Professor Deborah Pearlstein writes in *Just Security*, "The current scandal is different from these past examples [of scandals] in important ways. The United States did not secretly use military force in Ukraine, or secretly fund a rebel insurgency." She told *Business Insider* regarding President Trump's order to the US Navy not to take away a pardoned Navy SEAL's Trident pin, "The kind of crimes that are at issue here, these aren't marginal crimes," she said.

## Cardozo Ranked #22 in Hein Scholarship Rankings

Cardozo Law was ranked #22 in the country for scholarly impact in Heald & Sichelman's first-ever ranking of 100 American law schools based on Hein Online data.
