#### Professor Kate Shaw Speaks to ABC News on Supreme Court Reform

"Roberts' goal seems to be to keep the court out of the political fray, and with this speech Alito seems to be trying to plunge the court right into the center of it," Shaw said of Justice Alito's recent speech made to a conservative legal group. Shaw also spoke on [the likelihood of SCOTUS taking on a GOP petition](#) to review election results, noting that, "My guess is that they're waiting to see what happens with the election, and then when it's crystal clear it won't matter, the justices will deny [the petition]."
