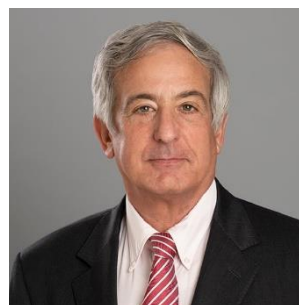

Professor Edward Zelinsky Quoted by Tax Notes on IRS Proposing New Guidance for Donor-Advised Funds

“From my perspective, yes, this makes things better in terms of the day-to-day implementation of these funds,” Zelinsky said. “But it doesn't address the fundamental issue that Congress has to address, which is that we impose very significant annual distribution requirements on private foundations and not on donor-advised funds, and that just doesn't make any sense as a matter of policy.”
