

Derrick Hamilton, Deputy Director of The Perlmutter Center for Legal Justice, Quoted in The New York Times on Ex-Detective Whose Overturned Murder Cases Have Cost New York Millions

Hamilton led the charge against ex-detective Scarcella from behind prison bars before he was exonerated in 2015. He told the Times that more defendants are waiting to have their cases heard. "It hasn't stopped," he said. "They're still coming."

"This is the most important bankruptcy case to be taken by the Supreme Court in decades," Foohey said.



Adjunct Professor Hillary Packer Speaks to The New York Times on Restorative Justice for Car Crash Victims

Considering the communication barriers in court cases between accident victims and drivers, Packer said her work at the Center for Justice Innovation sought to foster a place for an apology. "There's nothing that restorative justice can do in terms of the loss of life or a life-altering injury itself," Packer said. "But the fact that people were naming that barrier to communication had caused a lot of harm — could we do something about that?"
