Professor Andrea Schneider Appointed to Faculty, New Director of the Kukin Program

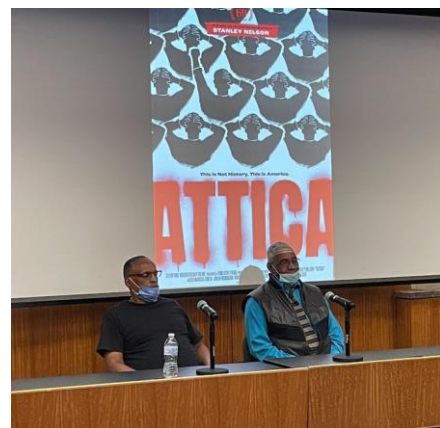
