Reinert said the biggest myth surrounding the bill in New York and other proposed reforms is that it will open the door to a flood of lawsuits in which police officers will have to pay damages to victims. “As a factual matter, even today when officers are sued, they never pay those judgments,” Reinert said. “They are always paid by the local department or the city or state. It’s a very convenient narrative to say this is threatening the livelihood of individual officers.”
