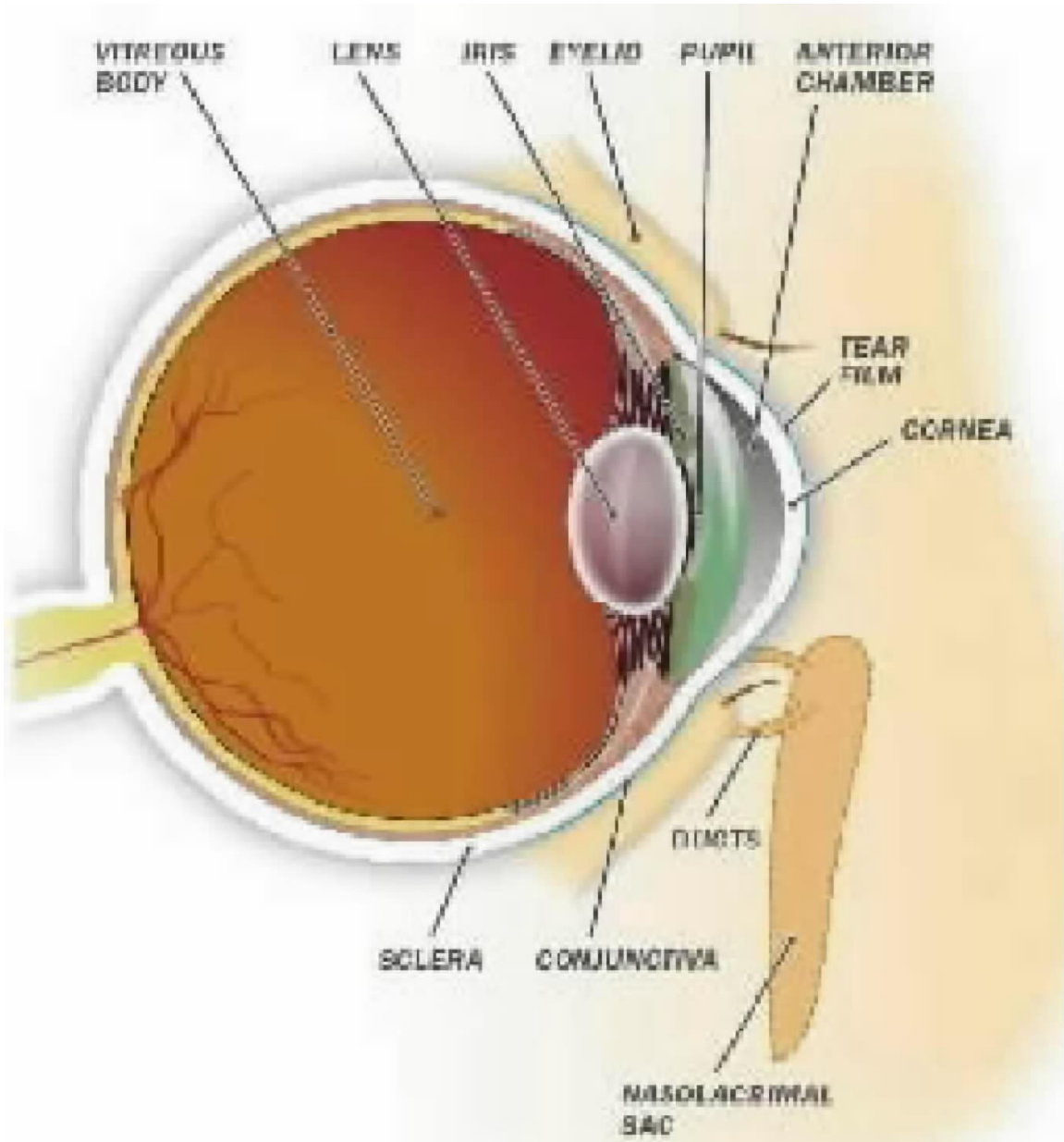

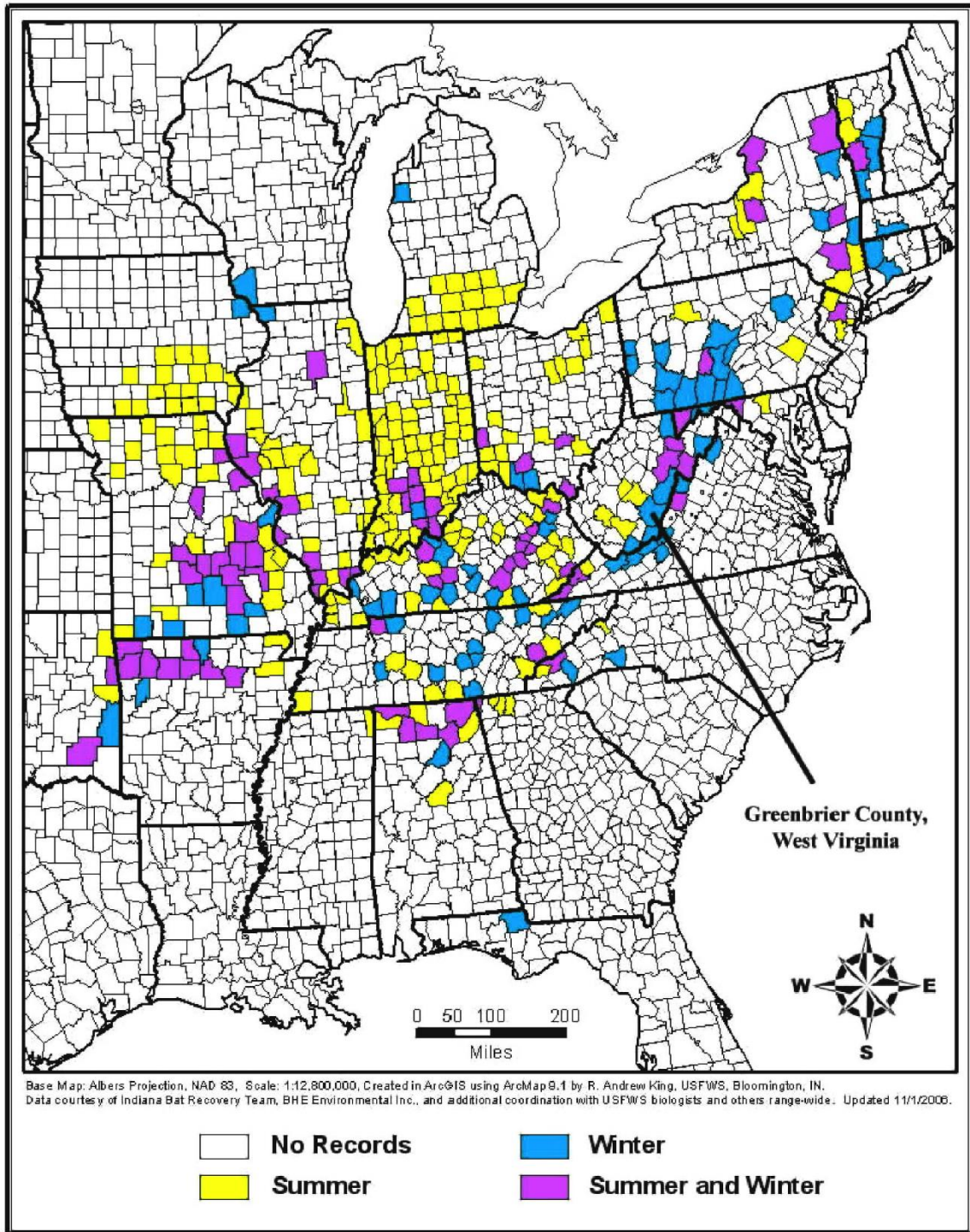

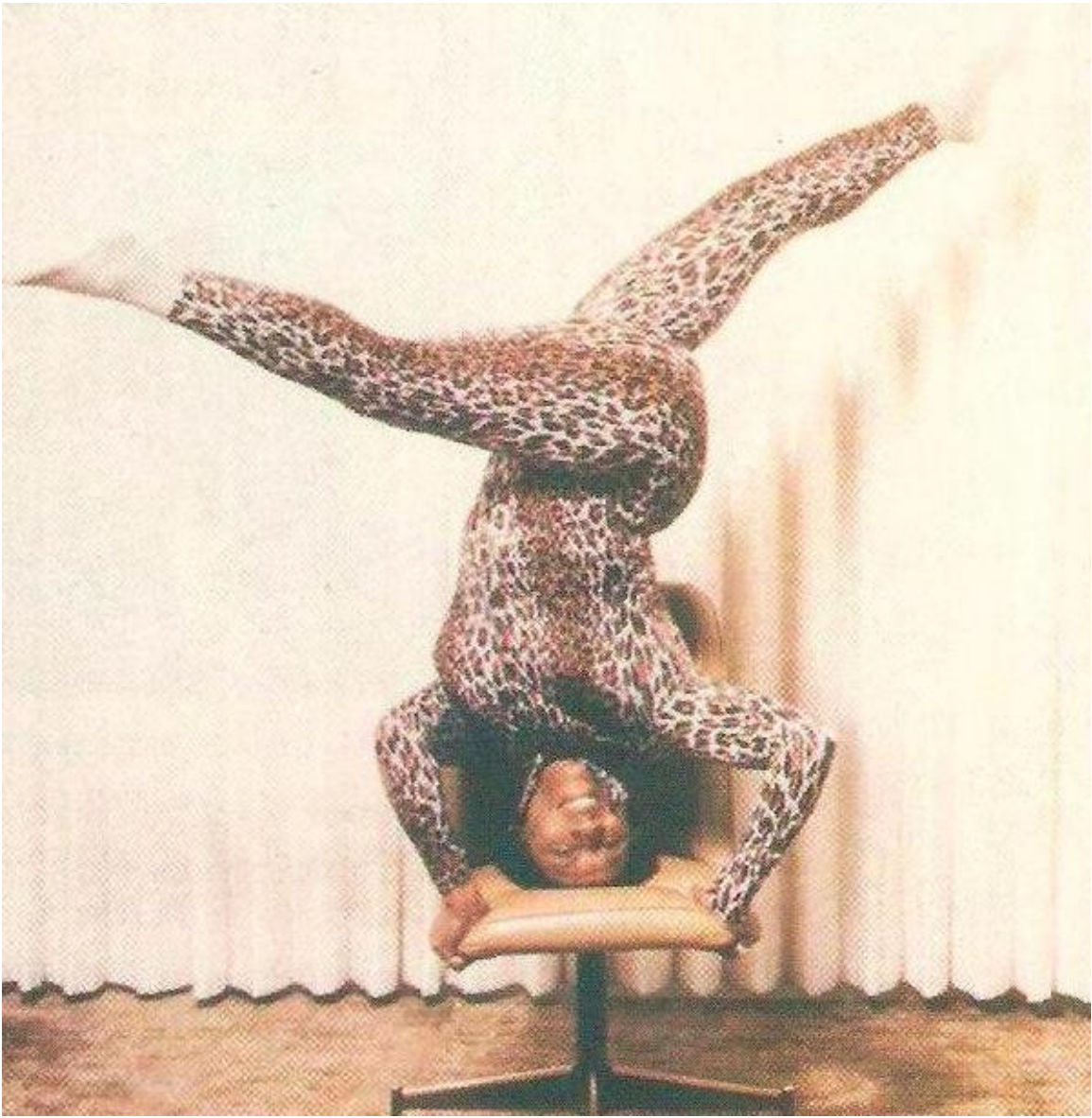



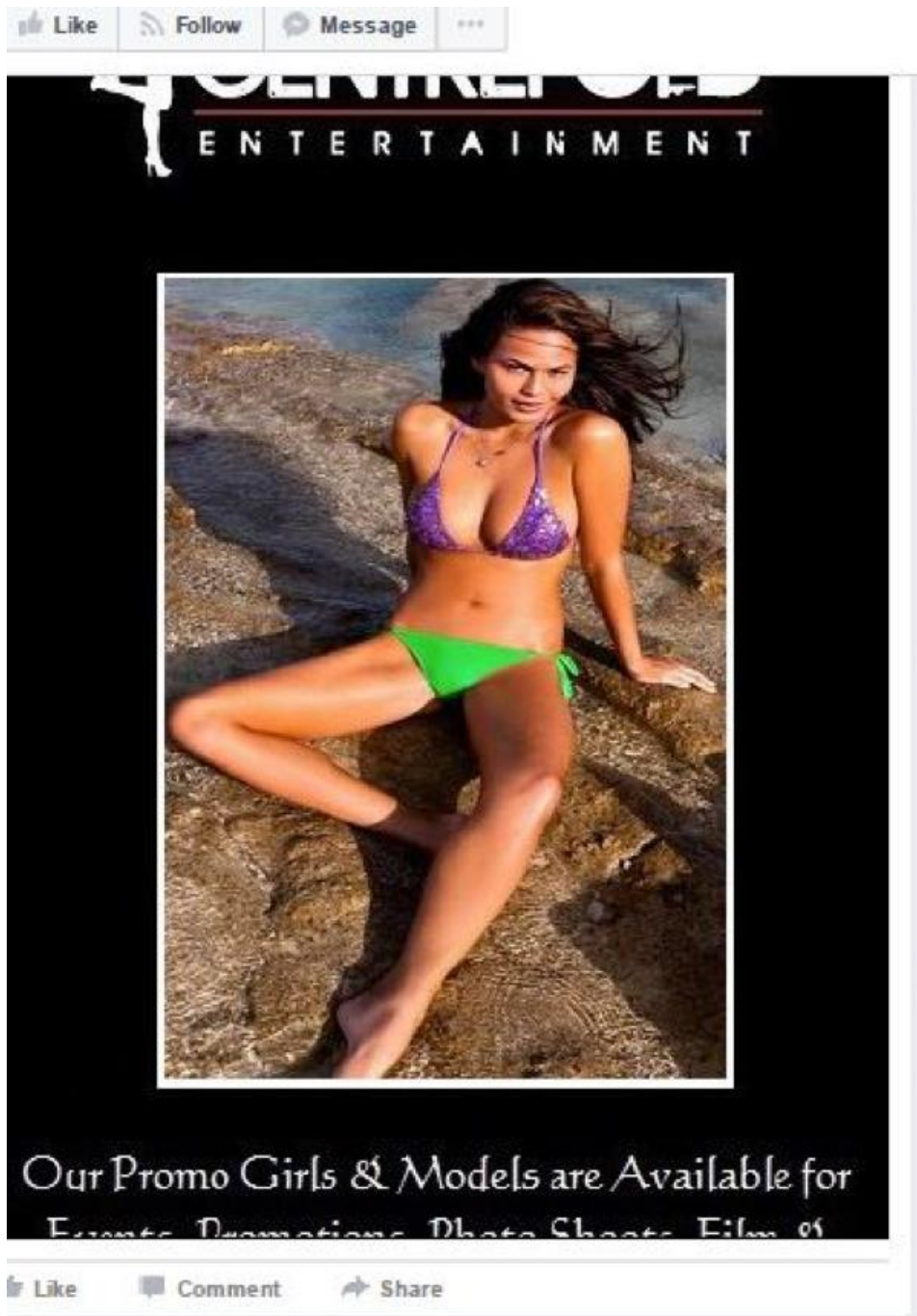

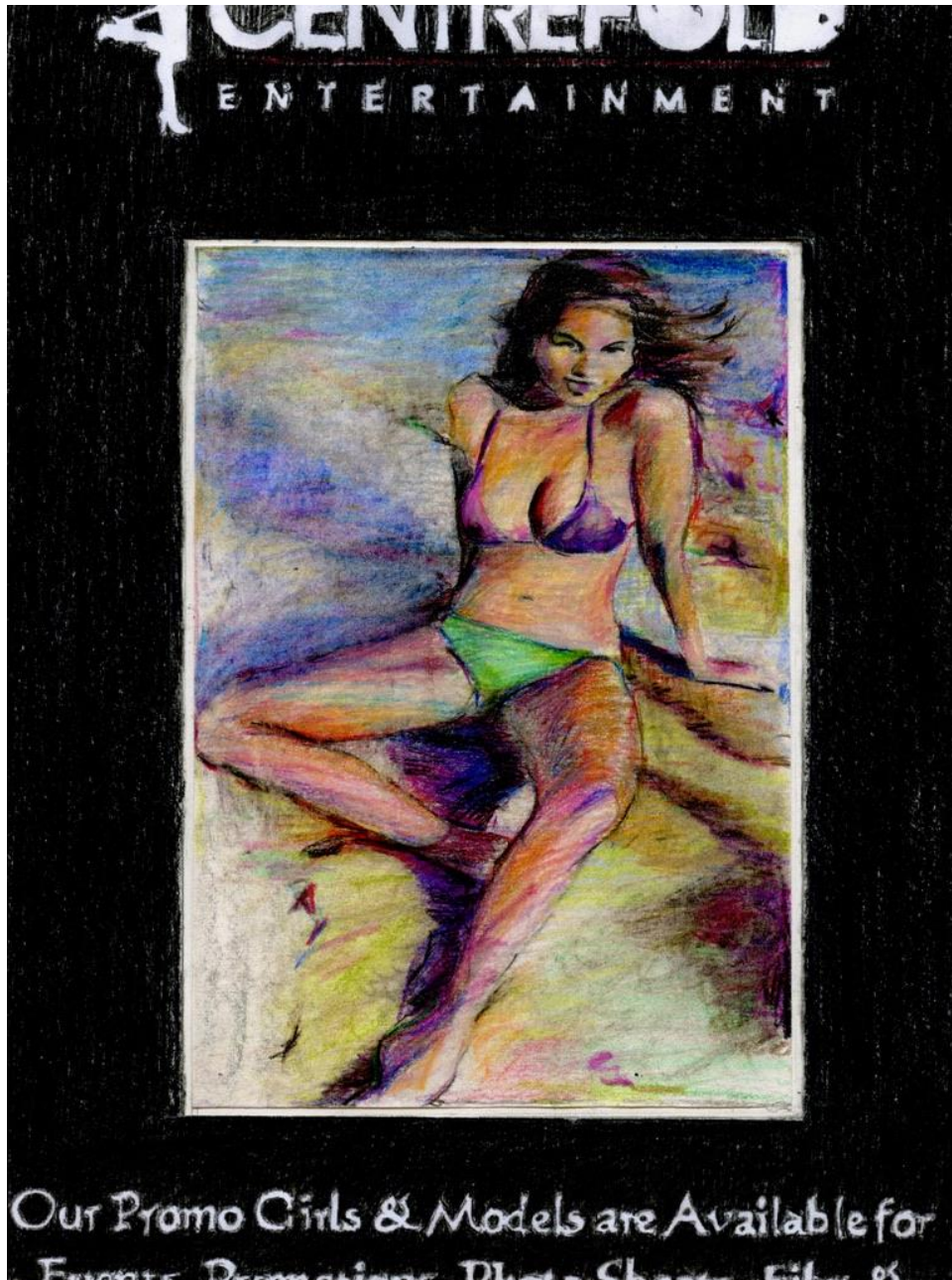
eFigure 7: Insertion by Justice Rares in Metro Business Centre v Centrefold Entertainment Pty [2017] FCA 1249.



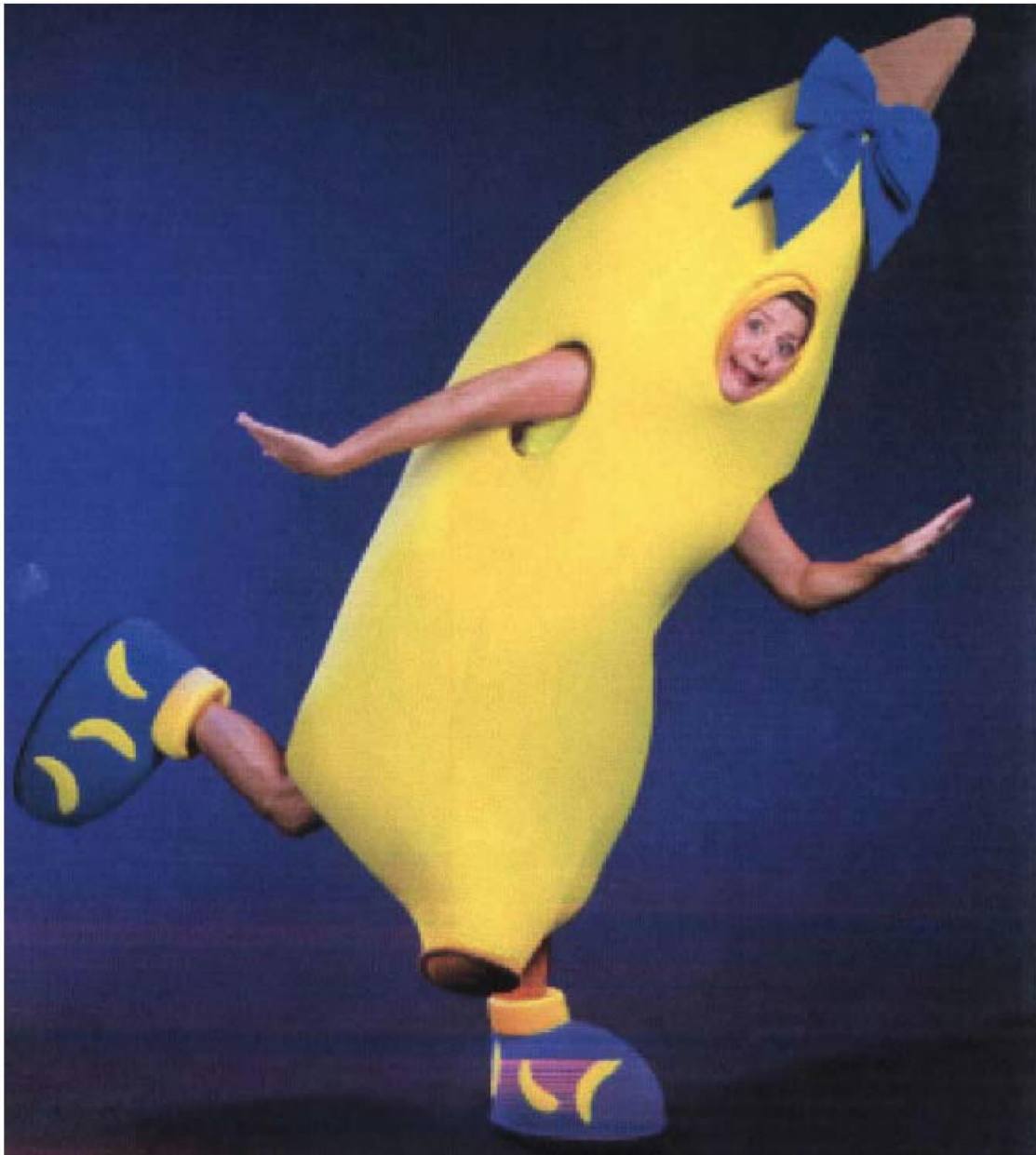

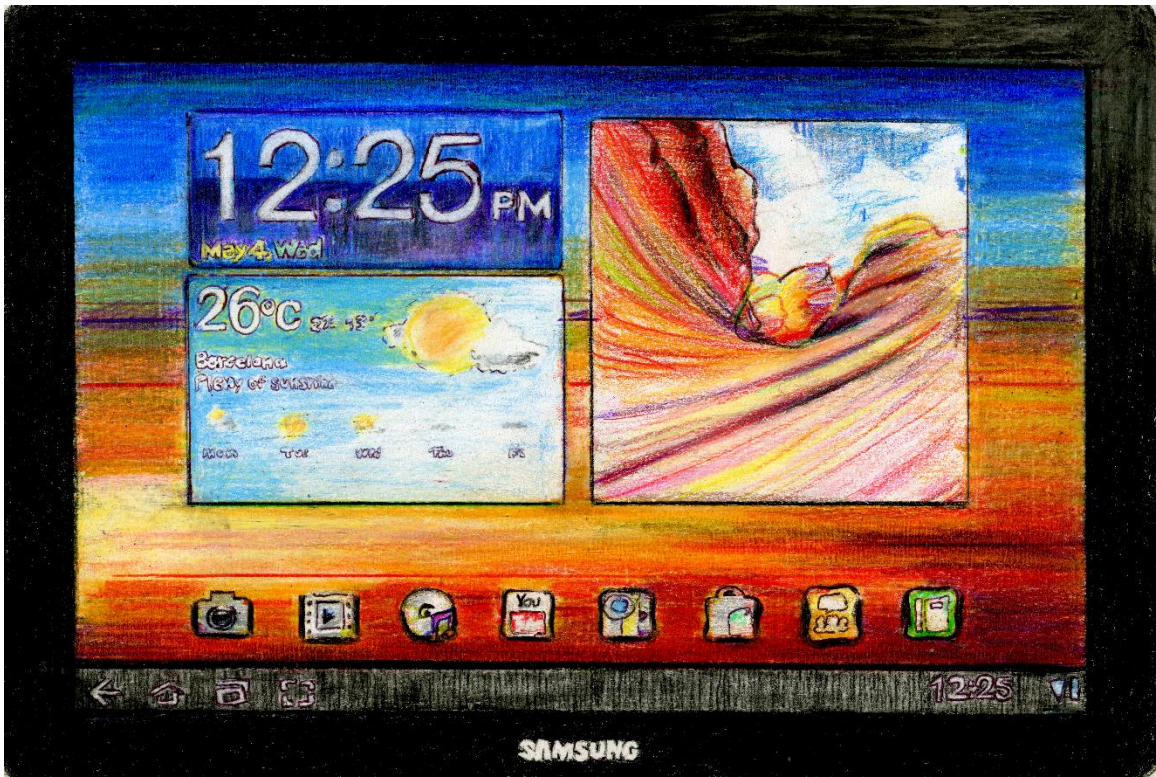

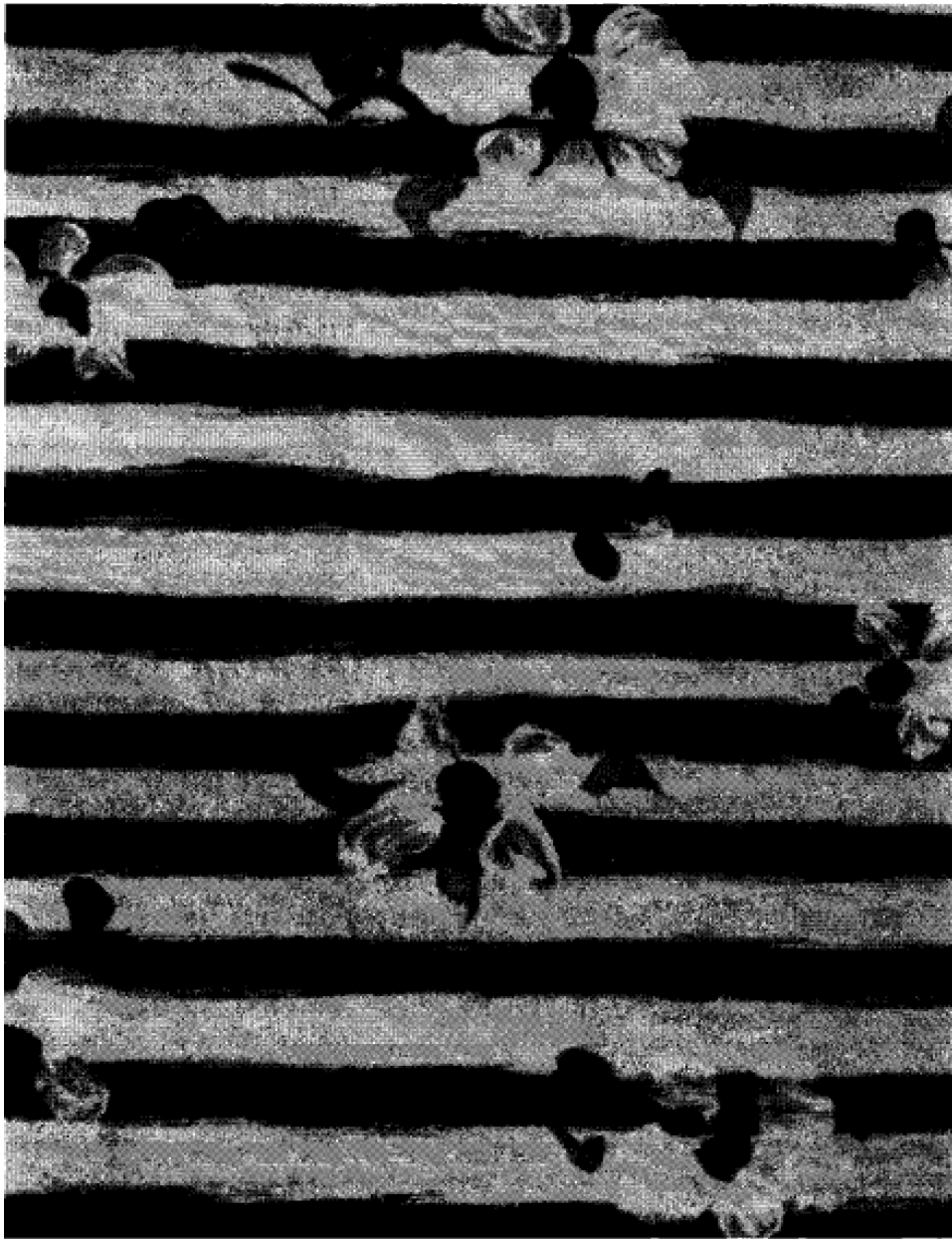
Figure 11: Insertion by Judge Josephine L. Staton in Michelle Hunt v Sunny Delight Beverages Co 2018 WL 6786265.



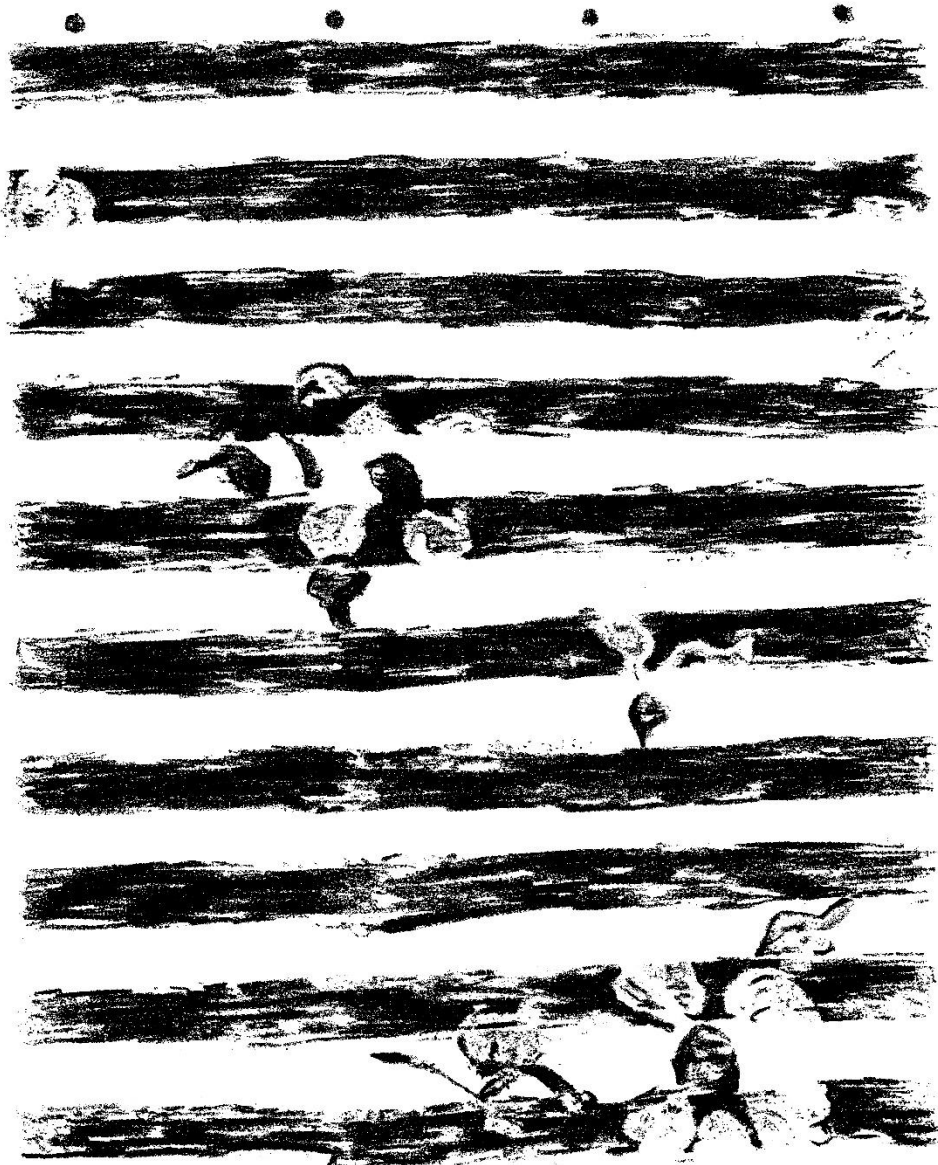

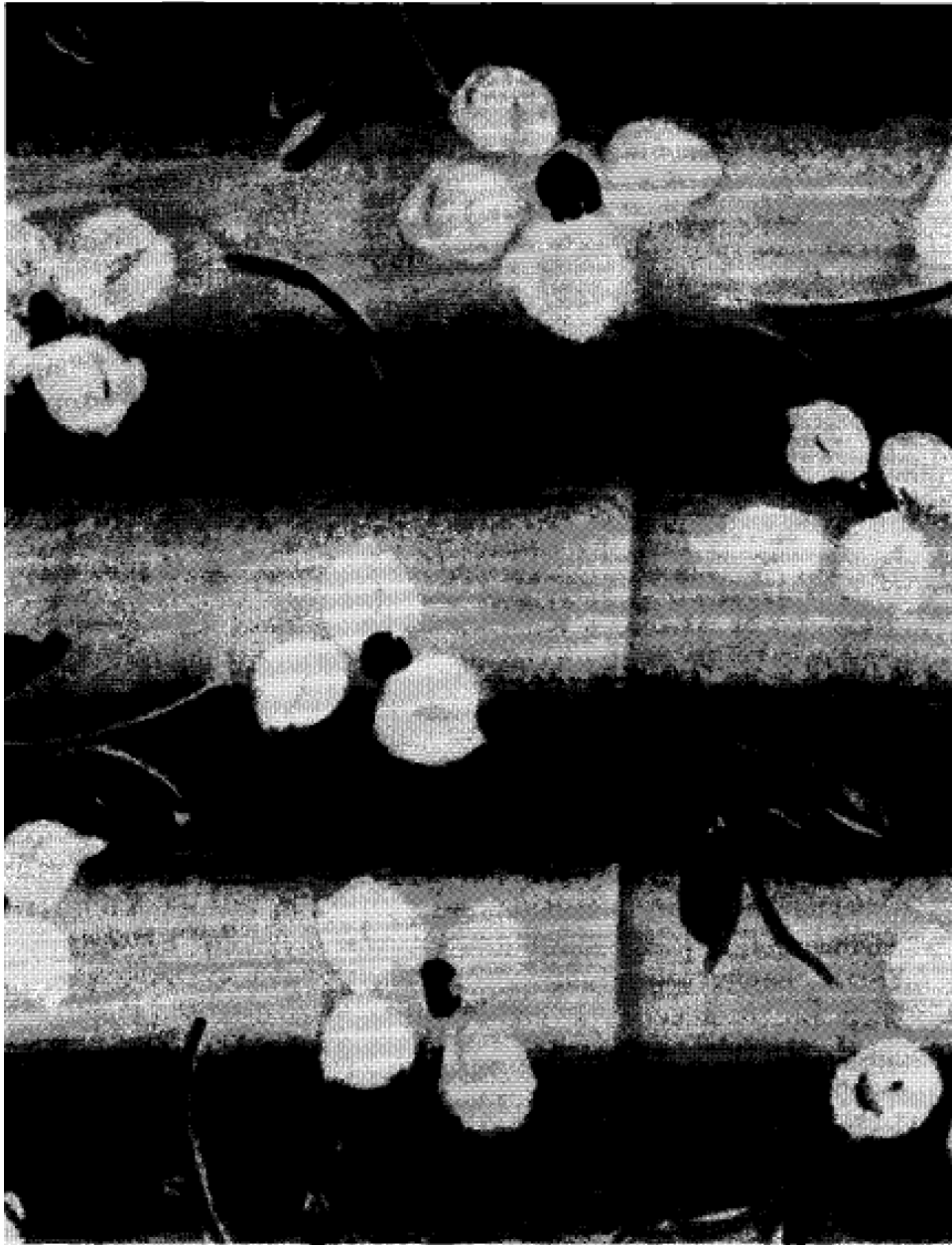

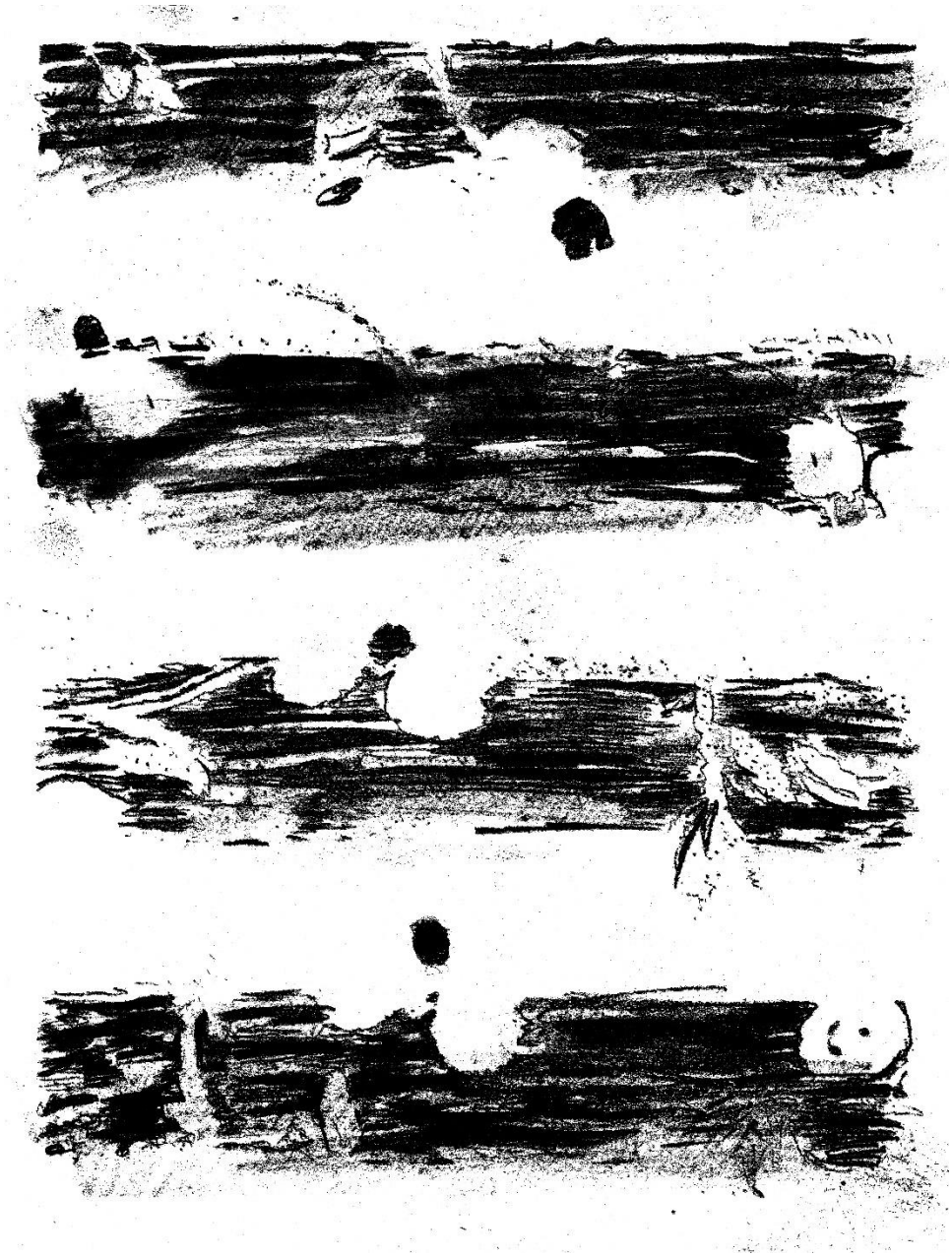
*Figure 13: Insertion by Deputy Judge Collins in *Designers Guild Ltd v Russell Williams (Textiles)* [1998] F.S.R. 803.*

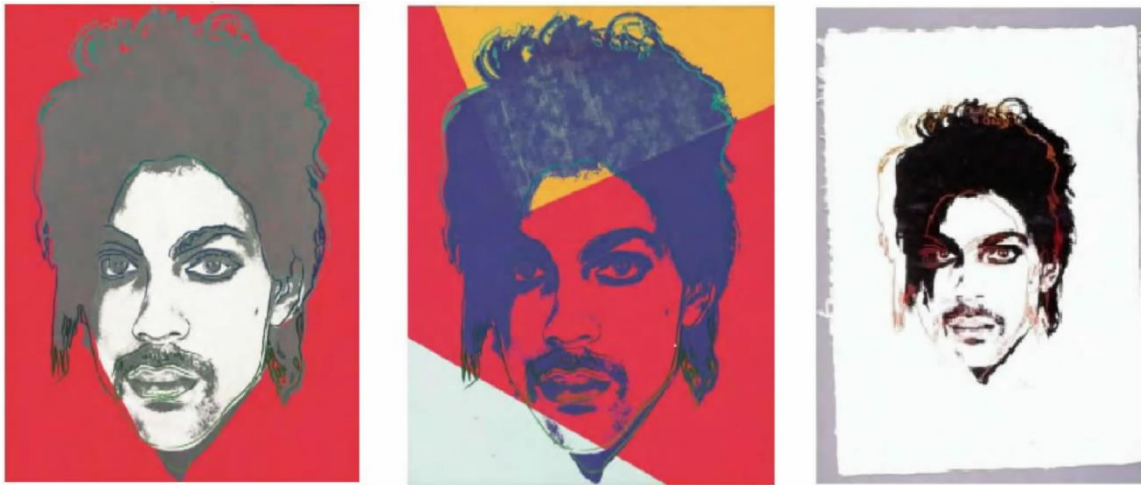

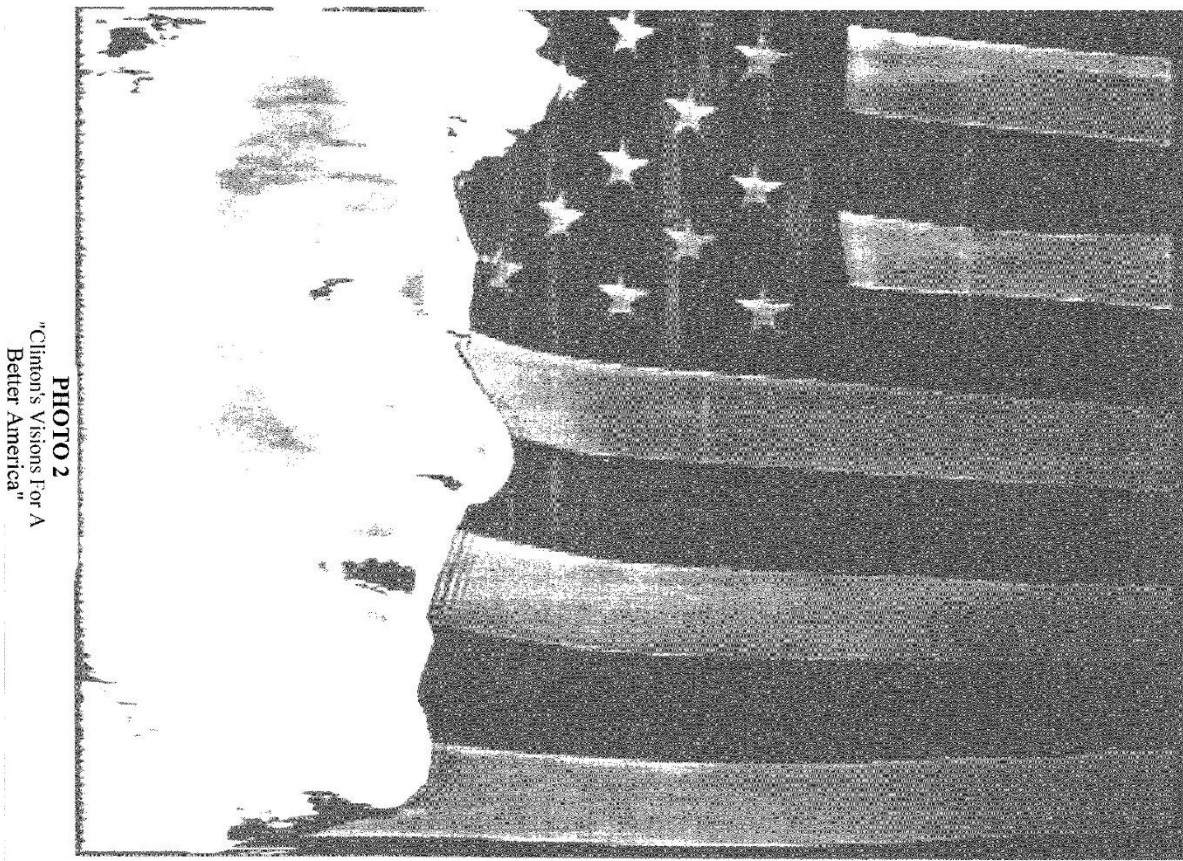
