## **Ira Dizengoff '92 and Betsy W. Dizengoff Establish Dizengoff Family Summer Public Interest Fund**



Cardozo School of Law is pleased to announce, with gratitude, that Ira Dizengoff '92 and Betsy W. Dizengoff have established a new endowment to expand the Public Service Summer Stipend Program at the law school, through the formation of the Dizengoff Family Summer Public Interest Fund. The fund will help students gain the legal experience they need to become successful lawyers in the public service law sector.

Ira is a graduate of the class of 1992, a Trustee of Yeshiva University and Chair of the Cardozo Board of Overseers. Betsy and Ira are parents of Reuben E. Dizengoff, Cardozo Class of 2018 and Sophie A. Dizengoff, Class of 2023.

This first award(s) from this endowment, starting in the summer of 2021, will enable Cardozo to continue its commitment to preparing students to become passionate advocates, dedicated to improving our legal system and the lives of the people they serve.
